- 1. Call to Order by John

- 3. Minister's Report Kathy submitted
 - a. Annual calendar/events updates. Fall Intentional Living begins 10/22/23
 - Mission Statement status report. Kathy shared statements and asked Board members to review them before sharing them with the congregation.
 - c. Promotions Assistant, Sherry, is focused on marketing and having engagement in Facebook, including concert payment link. Gail taking a vacation; Sherry is sub.

 - Unity Headquarters distributes social media; any contacts and engagement suggestions are shared with UWM. UWM supports ministers and ministries. Clarity in new design.
 - ii. Confusion over use of unity in other denomination names may make FoU difficult to identify as a Unity church.
 - iii. Shad Groveland noted the churches that came out of the pandemic the best focused on the in-person most and less energy in online, includes more financial support. People seeking churches-churches are not dead. How can we position ourselves for people to find FoU?
